- Upon completion of the SIG, the group may decide to continue to meet for new sessions.

- Listen attentively and empathetically when someone speaks. Give others equal time and opportunity to speak; avoid interrupting someone who has the stage, except to reinforce or support them.
- Teach, coach, and provide support to the learning process; introduce group members to new experiences, opportunities, and ideas.
- Provide helpful, meaningful, and constructive feedback; never put down, disparage, or condemn other group members' thoughts, ideas, or comments.
- Gain knowledge and be open to the expertise and feedback within your group; ask questions, try new skills, and learn from mistakes.
- Complete your action items on schedule; share your research, findings, and resources openly with other group members and collaboratively build on information that has been gathered.
- Enjoy the differences and diversity that each group member offers. Make it your purpose to create a collegial relationship with everyone in your group, even when your ideas differ.
